

Implementing Germline and Somatic Testing for Precision Medicine in Community-Based Prostate Cancer Care

Visiting Professorship Program for Process Improvement

Program Description

This program is open to community-based urology and oncology practices ("Organizations") who aim to implement or expand germline and somatic testing for patients with prostate cancer, when clinically recommended.

Accepted Organizations will be matched with a Visiting Professor: a clinical expert whose skills meet your Organization's learning needs and goals related to germline and somatic testing as you outline them in your application below. Your Organization will then receive funding and support to host a half-day education program with your Visiting Professor, held onsite or near your Organization, to address your learning needs and goals.

After the onsite program with your Visiting Professor, your Organization will develop and implement a small process improvement project related to germline and somatic testing. Throughout this process, you will receive guidance and support from PCF and your Visiting Professor.

Organizations will receive a grant of **up to** \$50,000 to support these activities, based on their budget estimate in the application below. PCF will **separately** cover the cost of the Visiting Professor's travel expenses, honorarium, room rental, AV, and other facilities costs for the onsite program; therefore, please **do not** include these costs in your budget estimate.

PCF will review proposals and notify applicants of decisions. The program will take place over ~18 months from Q1 2027 to Q3 2028.

Proposals are due September 9, 2026, by 11:59 PM Eastern Time.

We aim to improve our ability to identify patients who may need germline and somatic testing by implementing Y.” Outcomes also might include patient education materials, ongoing case reviews/rounds/clinical education sessions, etc. Metrics need to be trackable over time.

Participation in PCF Scientific Retreat and Video Interviews

In 2027, PCF will provide full registration and travel support for one participant per Organization to attend PCF Scientific Retreat, the world's foremost scientific conference on prostate cancer biology and treatment, held each autumn. After Organizations complete their projects, PCF will also conduct short video interviews in which participants describe their Organization's project goals, process, learnings, and any outcomes they want to highlight. These short interviews will be hosted on UroToday, a global education platform for urology and GU oncology.
